Prescribing cosmetic injectables, such as BTX (Wrinkle Reduction), requires a face to face consultation and treatment plan with a prescriber prior to any non-prescriber administering a prescription only medicine. When a non prescriber applies for a course, they must provide us with their prescribers name and registration number.
